

Browns Vibe Terms & Conditions

TERMS AND CONDITIONS – for outside catering

The following conditions will constitute a contract between Browns Vibe Outside catering and the client making the reservation:

1. Booking Catering

Please book a minimum of 14 days in advance to allow for sufficient preparation time, possibly including a meeting with Jenny. A deposit of 25% is required to secure a date. Final numbers need to be confirmed 14 days prior to the event.

2. Prices Private Chef

Because our menus are prepared specifically for each client, we can not offer a fixed price. All menus are priced according to the wishes and preferences of the client as discussed with Browns Vibe Outside Catering. We can arrange for waiting staff, which will be charged at cost price.

3. Area

We offer catering services throughout the South West . Delivery is normally free in the local area but may be charged at the discretion of the Company. Additional charges will apply for events in other areas of the UK.

4. Dietary requirements

We can cater for all specific dietary requirements, previous notice given in addition allergie

5. Deposits and Payments

A Deposit of 25% is required to secure a booking. Payment of the 25% Deposit signifies acceptance of the Quotation and the Terms and Conditions.

Quotations are valid for 14 days from the date of issue. The Company reserves the right to adjust unconfirmed quotations beyond 14 days if suppliers costs increase. Quotations are free and provided without obligation. Final numbers must be notified not less than 14 days before the function. Where numbers exceed the original quotation they will be charged pro-rata. Where numbers are less than the original quotation the cost will be reduced pro-rata by up to a maximum of 5%. Where increased numbers are notified less than 48 hours ahead of the function the availability of the extra food cannot be guaranteed.

6. Liability of Browns Vibe

If exceptional circumstances arise, which prevents the Company from fulfilling their Quotation, every effort will be made to provide an alternative, which is satisfactory to the client, or make a full refund. Nothing in these Terms and Conditions affects your Statutory Rights.

7. Cancellation

The following cancellation charges will apply once the booking has been confirmed, together with the none refundable deposit. Cancellations must be confirmed by post or email. Cancellation charges are as follows:

Number of days notification Cancellation cost
180 days plus None
Less than 180 days 25% Deposit
Less than 90 days Deposit + 25% of quoted price
Less than 30 days Deposit + 50% of quoted price
Less than 15 days Full quoted price

8. General

If you alter your booking, we will send you a need booking contract to sign, so that you know what you have booked and what you are responsible for each new booking contract signed by you and us will replace any previous booking contract The contract shall be subject to English Law, and disputes settled in the English Courts, please read the above terms and conditions in full and sign a copy for our files, keeping a copy for your own future reference
